Burn Permits

If you go to "Services" scroll down to "Burn Permits" and it explains what requires a burn permit. Basically, anything that emits an ember requires a burn permit. Solo stoves do emit an ember, propane fire pits do not, however, it may behoove anyone using a propane fire pit to obtain a permit, neighbors will call 9-1-1 for anything they see that looks like a fire. It happens all the time. A burn permit is \$ 10.00 through 12/31/2023 and you can apply online and pay online. If someone does not want to pay via paypal, or if you do not have internet, you can call me anytime to obtain a permit and I am happy to do it for you. The Fire Department also accept cash and checks at the office. Once you have a burn permit, you are directed to register your burn event by calling the "720" number at the top of the permit – it works much like caller ID and registers the burn to the address on the burn permit.

To explain further, the burn permit process is a wonderful tool for the fire district as well. We can log in at any time to see if someone has registered their burn event. This is extremely helpful with smoke report that the Fire Department receive.
